The landscape review aims to provide a horizontal view of the main issues and challenges in the area of EU Energy and Climate. It builds on results of previous ECA and EU SAIs reports, analysis of EU legal and policy instruments and Member States visits. The presentation will present the preliminary outcome of the EU SAI survey, focusing on what EU SAIs, including the ECA, have said they are covering in the area of energy and climate and highlight possible issues.





3.4 A fully integrated European energy market? Consequences to design future audits (*Mr. Xavier Lafon, SAI France*)

Energy market full integration isn't achieved. But current impacts have already serious consequences. Integration occurs through common or correlated market prices and through interconnections. National audits are limited in their ability to deal with integration. We would like to discuss the design of future national audits that could help fixing this problem. Three ideas will be proposed: share common audit methodologies (e.g. on nuclear dismantlement costs), produce national common analysis (e.g. on renewable real production costs), program parallel audits on specific integration issues (e.g. interconnections or capacity market).

3.5 Transformation of the energy system – towards a stable electricity transmission (*Mrs. Monica Rupprecht Hjort, SAI Sweden*)

The electricity transmission from Sweden's national grid, within Sweden and to Europe, is of great importance to the functioning of the electricity market. One challenge is to adjust the transmission system to more renewable energy, which in general makes the system more volatile. Svenska kraftnät (the Swedish Government Authority for the Electricity transmission system) is the authority responsible for ensuring that Sweden's transmission system for electricity is safe, environmentally sound and cost-effective. Svenska kraftnät is expanding the Swedish national grid to allow transport of electricity from new wind power, to eliminate bottlenecks in the grid, and to meet society's demands for a secure and stable electricity supply. The Swedish NAO has examined the preconditions given to Svenska kraftnät by the government, so that the authority may effectively meet the need for energy transformation. The audit has also included examination of what decision support Svenska kraftnät has produced to be able to effectively manage its activities.

3.6 Audit of the energy policy implementation (SAI Poland)

The energy policy in Poland is in 90% based on the production of coal-based energy (coal and lignite). At the same time we need to decrease the emission of gases produced in the coal burning process – according to the EU energy package – and to provide electricity generation capacity, so as to satisfy the national economy needs. Investment decisions in the energy sector are made mainly by the state controlled entities. NIK is experienced in auditing this subject area, which enables to assess the activities undertaken by the government and its subordinate institutions.

3.7 The Danish Government's implementation of the EU Energy Efficiency Directive (SAI Denmark)

The presentation concerns the performance audit report "Energy savings in public institutions" submitted to the Public Accounts Committee June 2016. The purpose of the audit was to assess if the government has strengthened the effort to achieve energy savings in the public sector adequately in line with the EU energy efficiency directive issued in 2012.

3.8 Challenges of German energy transition: Audit findings (Mr. Kay Scheller, SAI Germany)

The presentation first highlights the Federal Government's goal to reduce energy consumption in Germany and to increase the use of renewable energy resources. Then, the presentation outlines two key options the government may choose for achieving its objectives. In a next step, the German SAI's audit findings are presented.

3.9 Support of Energy Savings (Mr. Michal Rampír, SAI Czech Republic)

The Supreme Audit Office (SAO) scrutinized financial resources used for implementation of projects that aimed at energy savings and verified whether the national and EU targets in this area were achieved and whether the allotments had been used purposefully. Auditors scrutinized 25 projects and the grant awarding procedures. Also at the beneficiaries, the SAO audited 19 projects.

3.10 The Energy Efficiency Program of the Public Administration (SAI Portugal)

The Program aims to promote the rational management of energy consumption in public administration, increasing energy efficiency by 30% until 2020. The Program consists of a set of measures to be implemented by public services in the short, medium and long-term, in public buildings and equipment. The audit aimed to assess the achievement of the targets set in the Program and the actions developed for energy efficiency measures implementation through energy efficiency services, foreseen to be implemented.
